**INVITATION FOR BIDS**

**Complete Street Improvements**

The Town of Weymouth, as Awarding Authority, invites sealed bids for Complete Streets Improvements at various locations, in accordance with bid documents prepared by the Town's Engineering Division. To be eligible to bid, contractors must be approved by the MassDOT Highway Division's prequalification process, in accordance with M.G.L. Chapter 8, Section 8B. Improvements shall include, but not be limited to, installing at various locations: bicycle shelters, bus shelters, crosswalks, curb ramps, pedestrian crossing beacons (RRFBs), and speed feedback ("Your Speed") signage. Complete bid documents, including construction plans and specifications, may be obtained at the Office of Planning and Community Development, Third Floor, Town Hall, 75 Middle Street, Weymouth, MA, on or after Thursday, June 15, 2017, at 10:00 a.m. local time. Documents will not be mailed. All bidding shall be in accordance with M.G.L. Chapter 30, Section 39M, as amended to date.

A pre-bid conference advising bidders of the proposed work will be held at the Town Council Chambers, Town Hall, 75 Middle Street, Weymouth, MA, on Tuesday, June 20, 2017, at 10:00 a.m. local time. Questions and requests for interpretations may be submitted to Nicholas Bulens at [nbulens@weymouth.ma.us](mailto:nbulens@weymouth.ma.us) until 4:30 p.m. on Thursday, June 22, 2017. Answers and interpretations will be issued to bidders by Monday, June 26, 2017, at 4:30 p.m. local time.

Sealed bids must be submitted and received at the Office of Planning and Community Development, Third Floor, Town Hall, 75 Middle Street, Weymouth, MA, no later than Thursday, July 6, 2017, at 10:00 a.m. local time. Sealed bids must be accompanied by a deposit of not less than five percent of the bid price. A public bid opening will take place same day, Thursday, July 6, 2017, at 10:15 a.m. local time at the Council Chambers, Town Hall, 75 Middle Street, Weymouth, MA. The successful bidder will be required to furnish a payment bond of not less than 50 percent of the contract price. The successful bidder will be required to pay prevailing wage rates and furnish labor harmony and OSHA training certifications as provided in the bid documents.

This project is funded through the MassDOT's Complete Streets Funding Program. The Town of Weymouth reserves the right to reject any or all bids, waive minor informalities, and award the contract in the best interest of the Town.
