I hereby submit the following measure for consideration by Town Council:

"That the Town of Weymouth transfer the sum of \$750,000.00 from Free Cash for the purpose of funding costs associated with the purchase of a new fire engine for the Weymouth Fire Department."

A new fire engine is item #21 on the FY2025 – FY2029 Capital Improvement Plan. This new fire engine will replace Engine 7, a reserve engine that is a 2003 E-One Typhoon with 178,676 miles. It will be traded-in. The current front-line Engine 2, a 2014 Pierce Impel (refurbished in 2023) with 118,214 miles will be moved to a reserve status.

This measure requires a legal notice and public hearing.

At the time of this submittal the balance in Free Cash account is \$12,784,615.
